2012 Poster Art

The Festival will be held on Saturday, June 9, 2012 from 12:00 PM to 6:00 PM on the Mariposa County Courthouse lawn. The festival brings art and wine together in a beautiful setting. To submit your poster art, you must submit an application by April 1, 2012 and follow these instructions:

1. All submissions must be easily translated to a poster. Art should be in portrait orientation.
2. This art is juried based on a photograph of your poster art. You must submit a photograph or photographs for the jury. The photograph(s) must be a good representation of your entry. The photo(s) will not be returned unless you enclose a self-addressed, stamped envelope and a request that they be returned, with your completed application form.
3. The chosen art and artist will be featured at the festival with space, at no cost, for a booth for additional artist's work. See the application for artist booths at www.mariposarotary.org for further information about booth spaces and rules. Artists may request booth space concurrently with the submission of their work to the contest. Booth space requirements are separate from this submission.
4. Complete the attached application form and mail it with your photograph(s) to arrive by the April 1, 2012 deadline. All entrants will receive a response by email or telephone. If you wish, you may submit your entry at gave87670@mypacks.com.
5. The Event Coordinator reserves the right to exclude any vendor for any reason on the day of the event.
